This was the third dissenting comment from [REDACTED] within five minutes (previous two about a foul and following me down the field about not calling a hand ball). This one in particular was public, personal, and provocative, yelling 20 yards to me that I made a terrible call.

The second caution which lead to a send-off for second caution was in the 86th minute, where [REDACTED] swung his hands out and struck [REDACTED] defender in the face and mouth. This was done in a reckless manner without care for the safety of the opponent. After this second caution was issued, [REDACTED] was sent off.
