- MATCH CONTROL
 - PROTECT THE GAME - PROTECT THE PLAYERS
 - FAIR - CARELESS - RECKLESS - EXCESSIVE FORCE
- CLEAR CONSIDERATIONS
 - WHO PLAYS THE BALL - WHO INITIATES CONTACT
 - POINT OF CONTACT
 - INTENSITY - SPEED - FORCE
- ILLEGAL USE OF ARMS
 - CLEAR MOVEMENT OR SECOND ACTION
 - POINT OF CONTACT
- TEAMWORK
 - COMMUNICATE IMPORTANT DETAILS

- TEAMWORK – COMMUNICATION





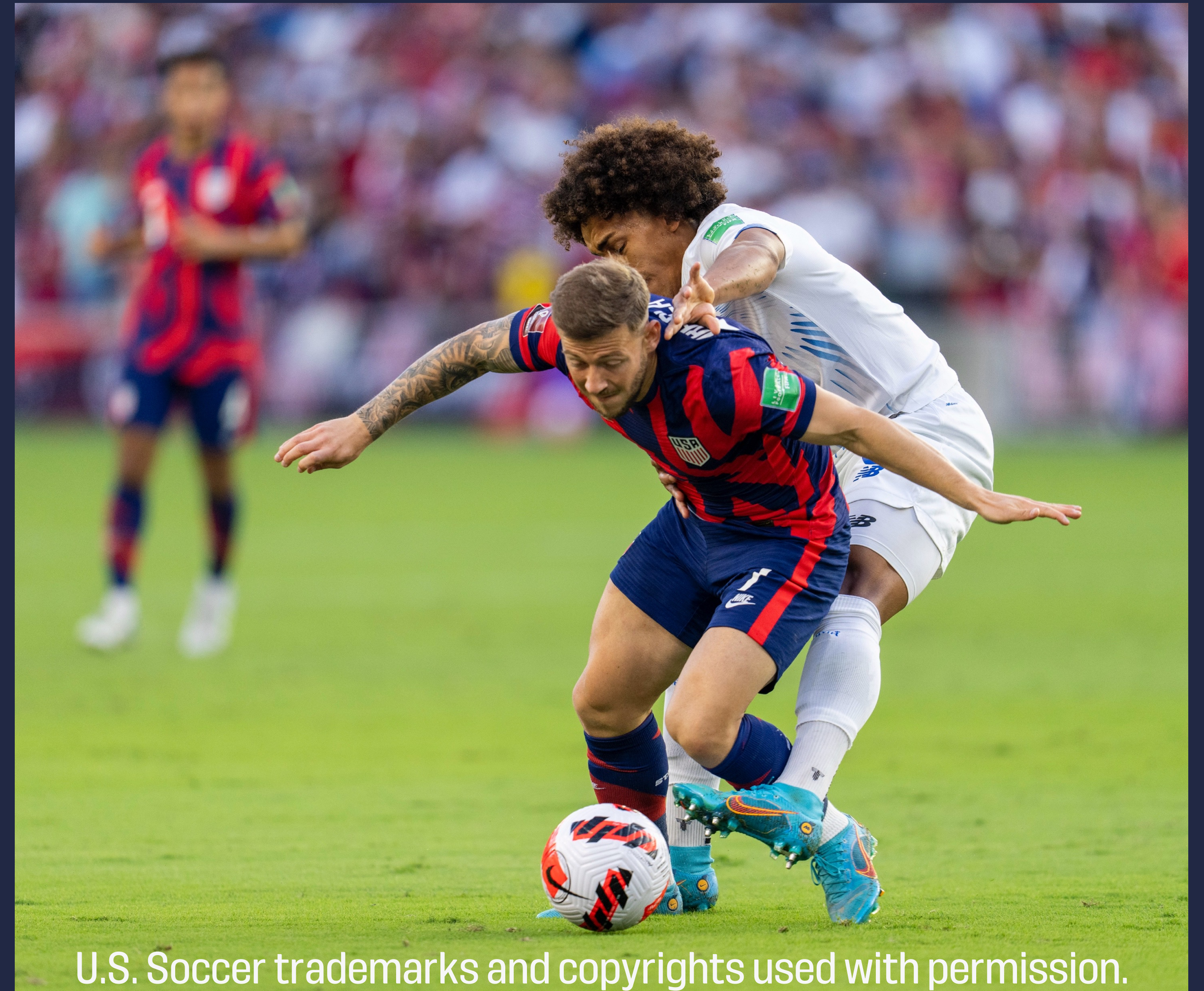

FIFA CONSIDERATIONS

- FOOTBALL UNDERSTANDING
- READING AND ANTICIPATION
- RED CARD – 100% OBVIOUS
- DOGSO
 - THE NUMBER AND LOCATION OF PLAYERS
 - DIRECTION / DISTANCE
 - CONTROL OR LIKELIHOOD TO CONTROL THE BALL
- SPA
 - DIFFERENT SCENARIOS
 - SPEED, SPACE AND OPTIONS OF PLAY
- PAI: ATTEMPT TO PLAY THE BALL
- TEAMWORK
 - PRIORITIES AND COMMUNICATION

- FOOTBALL UNDERSTANDING
- RESPONSIBILITY OF THE FULL TEAM
- INTERFERING WITH AN OPPONENT
 - CLEAR IMPACT
 - CHALLENGING – PREVENTING – OBSTRUCTING
- GAINING AN ADVANTAGE
 - DELIBERATE PLAY vs. DEFLECTION OR REBOUND
 - DELIBERATE SAVE
- TEAMWORK – COMMUNICATION

- FOOTBALL UNDERSTANDING
- USE CLEAR CONSIDERATIONS
- NATURAL POSITION OR MOVEMENTS (CLOSE TO / SUPPORT THE BODY / JUSTIFIABLE MOVEMENT)
- ADDITIONAL MOVEMENT
- TAKING A RISK – MAKING BODY UNNATURALLY BIGGER (EXTENDED ARM OR AWAY FROM THE BODY)
- POTENTIAL EXCEPTIONS (SELF / TEAMMATE)
